Fees & Payment: All membership contracts with Carambola include use of the pool & tennis courts and charging privileges at the pro shop. I understand that I am signing a one-year contract and that CGC is extending to me the privilege of paying the year membership fee in monthly or quarterly installments. I understand that if I leave the island or otherwise discontinue the use of my membership, I am still obligated to make all monthly or quarterly payments through the remainder of the contract year. I hereby give my permission to Carambola to debit my credit card (below) on the first of each month until all payments are made. Dues will be assessed each month or quarter regardless of whether I utilize the club facilities or not. I am also authorizing Carambola to debit my card for any other charges that I make at the club if I am more than 30 days late plus applicable late fees. I also agree that if my balance goes unpaid for 90 days or exceeds \$2,500, loss of playing privileges will result.
